South County Chamber: Peter said it had been given \$30,000 to assume ownership of and responsibility for the clock tower on Lorton Market St.

Discussion of possible "Mason Neck Day": Combine with tour of Gunston Hall? Charge \$20 to include MNCA membership? Or do smaller events, such as fishing?

Discussion of ways to boost MNCA membership: Need to publicize our past successes (blocking sewer, keeping the state park and the BLM horse barn open, etc), emphasize that MNCA has always "been there" and must be prepared for the next challenge.

South County Chamber – Clock Tower: Peter said the deal was completed--\$30,000 received to assume ownership of and responsibility for the clock tower.

Next General Membership Meeting: Date will be May 12 or 19, depending on guest-of-honor Gerry Hyland's schedule. Agreement to invite the candidates for his job to speak for five minutes each since the primary election will be June 9 (NB: four declared candidates so far). Noted that only 95 people voted in the Gunston precinct in the last Democratic primary.

Cub Scouts: Adam noted that the Mason Neck pack has been rechartered, with 16 scouts from 13 families, who are required to be MNCA members. Also mentioned that they have been given memorabilia from earlier Mason Neck Cub- and Boy-Scout troups, some dating back to the 1950s – perhaps these could be included in the Mason Neck history section of the exhibits room at Mason Neck State Park, which is under construction.

USO-veterans-Mason Neck: Missy reported that discussions with USO on providing events on the Neck for vets (such as the Hike&Shoot event last summer) have been put off till spring, assuming that spring will actually arrive. Marvin noted that he has heard many compliments about Missy's work on this issue.

He designed the memorial pro bono, then was hired to design the park layout The park would be financed by a bond issue but funds for the memorial would have to come from donations to the "Turning Point Suffragistes Memorial Association" and the cost is estimated at \$7 million. The target is to have it done by 2020, the 100th anniversary of the 19th Amendment. The project is supported by the League of Women Voters, which was also established in 1920.

Candidates Night: Agreement that it was very successful, with good attendance and good presentations by the candidates. Note was made of the many political signs on Gunston Road.

MNCA meeting signs: Rick suggested doing an inventory of our signs and ordering more if needed.

USO & Warriors in Transition: Noted that they are doing things on Mason Neck on their own.

Fort Belvoir: Scott mentioned hearing a presentation about what is happening there and suggested inviting the presenter to an MNCA meeting.

DEQ hearing on coal ash storage at Possum Point: Hearing is Dec. 8 in Woodbridge, Hillary plans to attend; any comments to DEQ due by Dec. 14. Dominion Virginia Power (DVP) has applied for permission to consolidate five storage ponds into one, which would then be covered. The plan includes releasing 2.53 million gallons per day of treated water for several months. There is a potential effect on Mason Neck because tidal action could bring the water to us.

Motion passed unanimously for a Resolution to DEQ stating that it should request
a full list of plans from DVP, that it approve each plan, and then monitor for
compliance. Also DVP should pay DEQ for the cost of doing the monitoring, i.e.,
no self-monitoring by DVP. (Marvin/Ann)

Email from Janet Cole suggesting that the Potomac(?) Riverkeeper speak at a board meeting—no objections, will be done.

Rt. 1/Gunston Cove Road Intersection traffic problem: Hillary has the letter from the Board ready to mail.

Boy/Cub Scouts update from Adam: They have nine new members, none from the Neck, so perhaps they should drop the requirement that the parents be MNCA members. Motion passed that the Scouts just suggest a \$20 donation to MNCA. (Bruce/Peter)

Dues postcard to membership: Bob suggested sending a card requesting payment of 2016 dues (\$20 per person) and stating reasons why residents should support MNCA.
