President Hillary called the meeting to order at 7:35 and the following were discussed:

**Minutes from**: Motion passed to approve (Marvin/Bruce)

Guest speaker: Nick Kuttner, Board member of Potomac Riverkeepers. Grew up in DC. Lives in Bellehaven. Noted that the Potomac provides 25% of river flows into the Chesapeake Bay. Potomac RK started in 2000, has focused till now on river upstream from DC. Model is the efforts to restore the Hudson River in NY, which began in the 1960s. Their efforts focus on three areas—Activism, Advocacy, and Legal Action (they have 15-25 cases on going at any time, have never lost a case, have \$1 million budget plus several million \$ of pro bono work), . Nick mentioned the Chesapeake Bay Agreement, signed by VA, DC, MD, PA, and DE—aimed at limiting input of nitrates, phosphorus, and sediment into the Bay. Noted that agriculture, esp. cattle, and acid mine drainage (mostly from closed mines) are important sources of pollution.

**DEQ Hearing on Coal Ash at Possum Point**: Dec. 8 meeting, Hillary attended, noted some complaints about the short notice for the meeting. DEQ will present its findings to the Water Board in Richmond on Jan. 14.

**Gunston Hall Master Site Planning:** GH has hired an excellent firm to draft the plan. They will have eight meetings ("Charettes") for different interest groups to attend and present their thoughts—the one for Mason Neck residents will be Jan. 20 at 7:30. The resulting plan will be announced on George Mason Day, June 11.

Postcard reminding people to pay MNCA dues: Dick will do revised draft tomorrow.

Gunston Hall: Scott (GH Director) gave an update on their Master Site Planning process. About 80 people attended the various public meetings with the planning firm. The overlay maps provided were very useful and some of the main conclusions were that the mansion should basically be kept as-is, that the "intimacy" of the site should be maintained, and that the "historic area" should be made to look more like it was in Mason's time. The planners will be back in April for more discussions, focused on the Visitor Center, and the final plan will be finished by George Mason Day in June.

**Possible extension of Metro's Blue Line to Woodbridge using the VRE tracks**: There is a Virginia Senate proposal to study this and Marvin proposed that MNCA support it with a letter to about half a dozen county and state officials. **A motion to this effect was passed (Marvin/Scott)** 

**Rt. 1/Gunston Road Intersection**: Hillary said that VDOT had sent an email confirming receipt of our letter and promising a response in 4-6 weeks.

**MNCA Newsletter?** Discussed, and agreed that, at least for now, a "year in review" would suffice, and could be included with the election mailer sent before our annual election meeting in May or June.

Mason Neck Eagle Festival on April 23: Motion passed to donate \$200 (Scott/Marvin); we will have a sign-up sheet for volunteers to man the MNCA table.

**Branches left by Gunston Road from Dominion's tree trimming:** Marvin suggested a letter to Dominion saying that we are happy about the trimming but the branches should be removed.

**GMU's School of Conflict Analysis and Resolution (S-CAR):** Hillary attended the official dedication today.

**MNCA membership and finances:** Bob said we have about 100 members and about \$2500 on hand (but we owe the Secretary almost \$800 for the last two postcard printing and mailings; the postcards go to about 1130 Mason Neck addresses.

**South County Federation:** Peter said it now charges \$50 for a lifetime membership. Also that it is looking into proposals for the concrete plant on Old Colchester.

Marvin suggested a letter to Surovell/Albo/Storck saying VDOT hasn't followed through.

"Candidates' Night", September 27: Del. Albo, Sup. Storck, and School Board member Corbett-Sanders have confirmed; Rep. Beyer has a previous commitment.

Airplane Noise from Reagan National: The FAA is considering changes that would hace aircraft fly further south before turning west, which would mean more noise for Mason Neck. Agreement that MNCA needs to register its opposition to the change with our representatives (Beyer, Surovell, Albo, Storck) highlighting the environmental sensitivity of the Neck and the possible harm to wildlife, including the eagles which nest at the Hartwell refuge and the many migratory birds that stop on the Neck to feed and rest.

**Mason Neck State Park** — **10-year plan in preparation**: Citizen input is invited, public meeting will be held on November 10.

**BLM** – **Public Lands Day, September 24**: BLM has requested a \$400 donation – which will be reimbursed later – to buy food for the volunteers. Motion passed to make the donation (Bruce/Marvin)
